The conference is dedicated to the 25th anniversary of the adoption of the Rome Statute of the International Criminal Court (ICC) and focusing on the current challenges of international criminal justice from the ICC's point of view. Although there is no doubt that the adoption of the Rome Statute was a considerable success towards putting an end to impunity of perpetrators committing the most serious crimes of concern to the international community, there is still a long way to go for the ICC to fulfil its mandate. Therefore, the conference provides room for discussion on the permanent problems of the ICC related, inter alia, to jurisdiction, complementarity, its relationship with the United Nations Security Council, immunity, cooperation with States with special regard to Africa and selective justice, while it is also devoted to the latest topical issues before the ICC. All in all, the conference is a stocktaking of the ICC's achievements reached so far and of proposals of possible solutions to overcome its hurdles.
